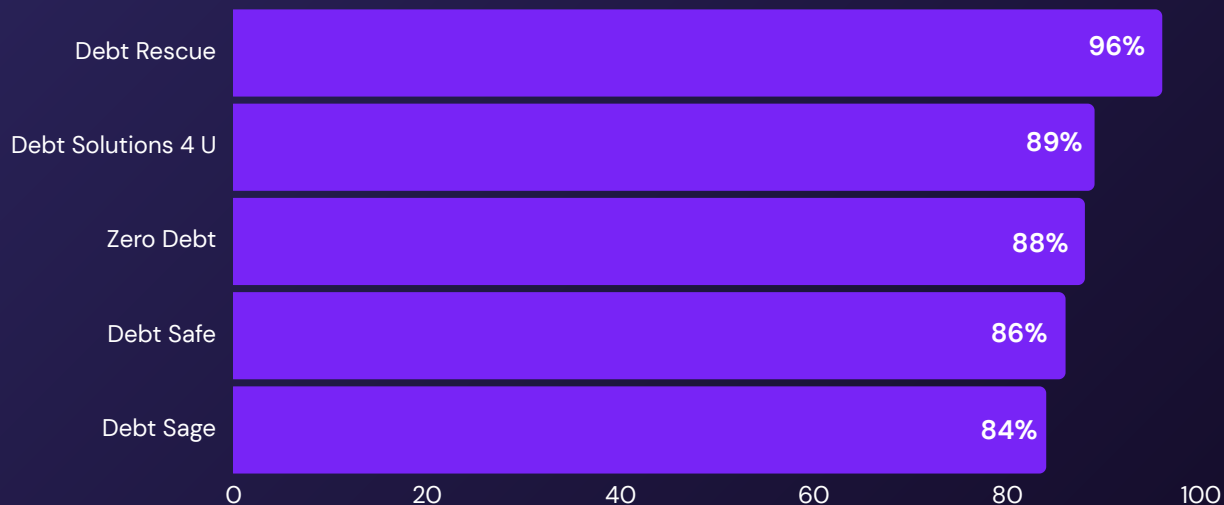
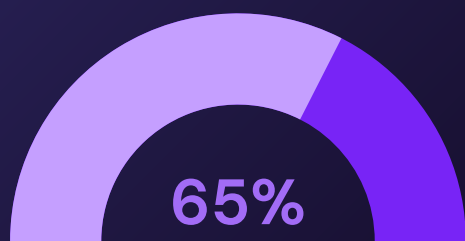

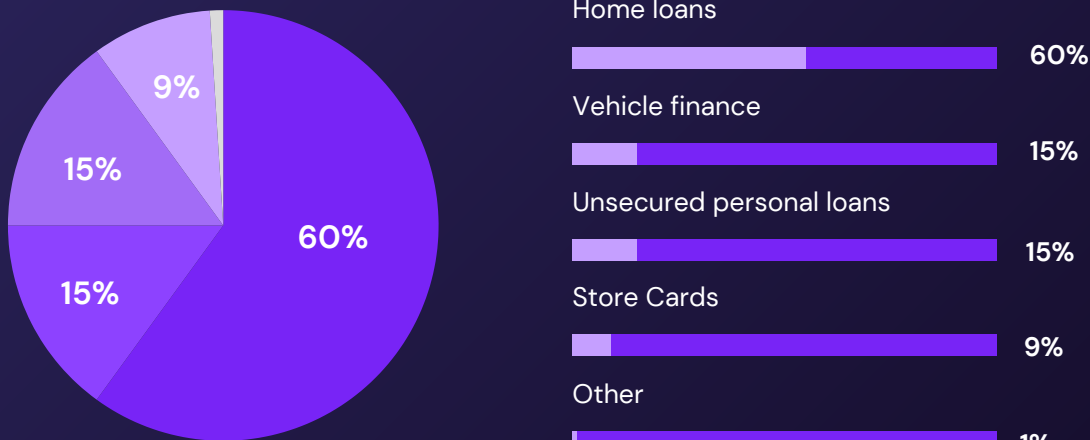


SUCCESS RATE IN SOUTH AFRICA

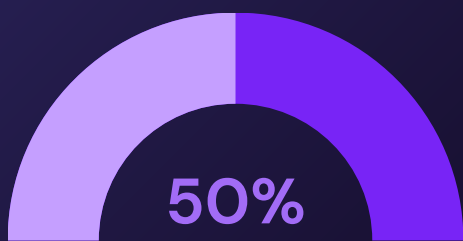


Around 60–65% of consumers who enter **debt review** successfully complete the process.
